3 TECHNICIAN 2: Backup is rolling.

6 SERGEANT POLITE: Thank you. Good morning and
7 welcome to the remote hearing on the Committee on
8 Environmental Protection. Will Council Members and
9 staff please turn on their video at this time. Thank
10 you. To minimize disruptions please place all cell
11 phones and electronics to vibrate. Chair, we are
12 ready to begin.

13 CHAIR CONSTANTINIDES: Thank you Sergeant at Arms.
14 Thank you. Good afternoon everyone. My name is
15 Constantinides. I am Chair of the Environmental
16 Protection Committee and today, today we'll hold
17 we'll hold a hearing and vote on the planned
18 transitional use of Rikers Island from a correctional
19 facility holding detainees to renewable Rikers, a
20 sustainable but doable contribution to New York
21 City's green future. As I said it just two weeks ago
22 Rikers Island has a notorious past, today's action
23 will help us turn Rikers Island into an integral
24 contribution towards our sustainable future. Just 13
25 months ago we introduced the Renewable Rikers bills,

2 which help formulate a new vision for the island.
3 Committees historically targeted by the Criminal
4 Justice system. Communities too often burn it with
5 the city's most polluting infrastructure. The
6 communities facing Environmental Justice challenges
7 can look forward to some measure of relief. Intro
8 1591-B would require the Commissioner of
9 Environmental Protection in consultation with the
10 Commissioner of sanitation to assess the feasibility
11 of constructing a wastewater treatment facility on
12 Rikers Island. The study would consider population
13 projections and possible alternatives for wastewater
14 treatment, and disposal as well as minimum capacity
15 and maximum capacity a wastewater treatment facility
16 on Rikers Island should have, how much wastewater
17 might be able to be diverted from other facilities
18 and the capacity on Rikers Island for the capture of
19 combined sewer overflow or CSO. This required study
20 will also consider the potential for organic waste
21 recycling via composting operations, organic
22 codigestion and bio solids we use. This study will
23 also assess in a separate review the presence of
24 methane, the potential installation of methane
25 recovery systems, and the use of such systems for any

wastewater treatment facility. Finally, the Rikers Island Advisory Committee will make recommendations to the Department regarding the Feasibility Study and a separate review regarding the presence of methane. Individuals whose lives have been affected by the Justice System, Environmental Justice organizations, environmental organizations, planning organizations and labor organizations and help re-imagine a new Rikers Island. It needs posting the oldest sewer plants and final towage potential relief, and Rikers Island can reflect the hope for a better, greater future. According to NRDC, The National Resource and Defense Council a disproportionate percentage of people in jail on Rikers Island are black and black mixed despite making up for more than half of New York City's population. Furthermore, as late as last year the midst of the COVID Pandemic approximately 72% of the people held on pre-trial detention were also held because they were unable to afford money for bail. This victory in the campaign to close Rikers Island Jail and transform the Island into a model of green infrastructure, and jobs coming from years of organizing a front line and bond at the Justice communities and organizations directly

2 impacted by incarceration there. I want to recommend
3 a yes vote on all proposed legislation. Before we do
4 that I just want to thank the committee staff Samara
5 Swanston our Investigative Attorney, our Policy
6 Analyst Nadia Johnston and Ricky Charla, our
7 Financial Analyst Jonathan Seltzer, Bradley Reed,
8 August Waite, (sp?) Locanda Bell (sp?) Laura Copa
9 for all her great work, all the attorneys that were
10 involved, my Legislative Director and Counsel Nichola
11 Widzowski and my entire team and lastly our Speaker
12 Corey Johnson who is helping us move this forward and
13 moving New York City potentially being green, and
14 green new deal direction. So with that I recommend a
15 yes vote on this bill today.

16 WILLIAM MARTIN: Good after noon (coughs) excuse
17 me. William Martin Committee Clerk roll call vote
18 Committee on Environmental Protection Proposed
19 Introduction 1591-B. Chair, Constantindies.

20 CHAIR CONSTANTIINIDES: I Vote aye.

21 WILLIAM MARTIN: Levin.

22 COUNCIL MEMBER LEVIN: Permission to explain my
23 vote.

24 CHAIR CONSTANINIDES: Certainly, Council Member.

2 COUNCIL MEMBER LEVIN: Thank you very much Chair.

3 I just want to thank you Chair, I want to thank the
4 Speaker, I want to thank Committee Counsel Samara
5 Swanston, and all the advocates who are pushing to
6 make sure that we as a Council pass this legislation
7 but also that we as a city see government make good
8 on the commitments that we made when we, when we
9 voted on the Borough Based Jails Plan back in 2019
10 that... To ensure that Rikers is not going to be
11 Rikers Island. Some steam for the developers to
12 build luxury housing or for some people to make
13 money. There was a lot of, a lot of discussion about
14 that at the time, and we insisted and asserted that
15 Rikers was going to be closed that it was no longer
16 going to be a jail, but this might take time a matter
17 of years. But we were doing, we were putting that
18 plan into practice and starting the gears in motion
19 to make sure that that happens, and that it happens
20 in a way that is...it can't be reversed. We know that
21 we're not going to be in office next year. The stats
22 will be in office and there will be a new mayor a new
23 administration, but if we get things going in a way
24 that is, that is irreversible and on a road towards
25 sustainability, you know, that's what we should be

2 doing, and so this, the passage of this bill today is
3 an important part of that, and it's also... It's the
4 right thing to do. We know that the greatest impact
5 that our city has on climate change is how we consume
6 energy, and we have 8-1/2 million people in this
7 city, and then most that we can be off the grid as it
8 relates to our fossil fuels is our...that's our down
9 payment to future generations in our city and in our
10 entire world, and we're the largest city in America.
11 We've been leading by example. This is a once in a
12 century opportunity not just directing when it comes
13 to Criminal Justice reform, but also when it comes to
14 how we, how we combat climate change in unique ways.
15 So, Chair, I want to thank you. This is an important
16 part of you legacy as Chair of this committee, and I
17 want to thank Samara for all the work that she's
18 done, Committee Counsel and your staff and then I
19 vote aye on this today. Thank you.

20 WILLIAM MARTIN: Thank you. Menchaca.

21 COUNCIL MEMBER MENCHACA: Alright. Thank you.
22 Chair, thank you.

23 WILLIAM MARTIN: Darma Diaz.

24 DARMA DIAZ: I also vote aye.

2 WILLIAM MARTIN: Thank you. One moment. Okay, by
3 a vote of 4 in the affirmative zero in the negative
4 and no abstentions both Introduction 15 and 1-B has
5 been adopted by the committee.
