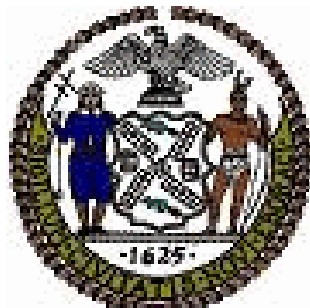

Whereupon on motion of the Speaker (Council Member Miller), the Clerk of the Council adjourned to meet again on April 24, 2002.
