A Local Law in relation to a street name, John Cardinal O'Connor Way, Borough of Manhattan.

Be it enacted by the Council as follows:

Section 1. The following street name is hereby designated as hereafter indicated:

| New Name | Present Name | Limits |

| John Cardinal O'Connor Way | 50 th Street | Between 5 th Avenue and Madison Avenue |

§2. This local law shall take effect immediately.
