Resolution approving the decision of the City Planning Commission on an application submitted by the Department of Housing Preservation and Development, ULURP No. C 030315 HAK, approving the designation of 342, 344, 346, 348, 350 and 352 Wilson Avenue and 1341 Gates Avenue (Block 3333, Lots 33-39), Brooklyn, as an Urban Development Action Area, approving the project for the area as an Urban Development Action Area Project, and approving the disposition of 342 Wilson Avenue (Block 3333/Lot 33), Brooklyn, to a developer selected by the Department of Housing Preservation and Development (L.U. No. 398; C 030315 HAK).

WHEREAS, the City Planning Commission filed with the Council on May 28, 2003 its decision dated May 21, 2003 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 342, 344, 346, 348, 350 and 352 Wilson Avenue and 1341 Gates Avenue (Block 3333/Lots 33-39), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of 342 Wilson Avenue (Block 3333/Lot 33) to a developer selected by the Department of Housing Preservation and Development (the "Disposition"), to facilitate the development of a six-story building, tentatively known as Gates Gardens, with 62 units of housing for low-income, elderly persons to be developed under the Federal Section 202 Program, Community District 4, Borough of Brooklyn (ULURP No. C 030315 HAK) (the "Application");

WHEREAS, the Application is related to ULURP Application No. C 861009 PPK;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

| The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law |
| The Council approves the disposition of 342 Wilson Avenue (Block 3333/Lot 33) to a developer selected by the Department of Housing Preservation and Development. |
