WHEREAS, the Landmarks Preservation Commission filed with the Council on January 20, 2011 a copy of its designation dated January 11, 2011 (the "Designation"), of the Haskins & Sells Building located at 35 West 39<sup>th</sup> Street a.k.a. 35-37 West 39<sup>th</sup> Street, Community District 5, Borough of Manhattan as a landmark, and Tax Map Block 841, Lot 18, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on March 18, 2011, its report on the Designation dated March 16, 2011 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on April 4, 2011; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
