A Local Law to amend the administrative code of the city of New York, in relation to the provision of mental health services for children visiting incarcerated individuals

Be it enacted by the Council as follows:

Section 1. Chapter 1 of title 9 of the administrative code of the city of New York is amended by adding

a new section 9-163 to read as follows:

§ 9-163 Mental health services for child visitors. The commissioner of correction shall establish a

mental health services program at city jails for visitors under the age of 18. Such program shall provide

referrals to mental health services and, whenever practicable, onsite mental health services. Participation in

such program shall be on a voluntary basis.
