A Local Law to amend the administrative code of the city of New York, in relation to amending a transcript of a record of death for a death caused by COVID-19

Be it enacted by the Council as follows:

Section 1. Section 17-169 of the administrative code of the city of New York is amended by adding a

new subdivision e to read as follows:

e. The department, in accordance with the authorization in section 207.13 of the New York city health

code to waive any fee to correct a transcript of a record of death for good cause, shall not charge a fee for an

amendment of such a transcript that would change or supplement the cause of death by citing the disease

caused by the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) known as COVID-19, or to

health complications related thereto.

§ 2. This local law takes effect immediately.
