A Local Law to amend the New York city charter, in relation to the date by which the council shall submit recommendations in regard to the preliminary budget

Be it enacted by the Council as follows:

Section 1. Subdivision b of section 247 of the New York city charter, as added by vote of the

electors on November 7, 1989, is amended to read as follows:

b. Findings and recommendations of the council, or its committees, including recommendations

for any changes in the unit of appropriation structure which the council deems appropriate, shall be submitted to the mayor and published not later than the [twenty-fifth day of March] <u>first day of April</u>. The net effect of the changes recommended by the council in the preliminary capital budget shall not result in a capital budget which exceeds the maximum amount set forth in the preliminary certificate issued pursuant to section two hundred thirty-five of this charter.

§ 2. This local law takes effect immediately, except that if it becomes law after March 25, 2021, it is retroactive to and deemed to have been in full force and effect as of March 25, 2021.
