WHEREAS, the Landmarks Preservation Commission filed with the Council on February 15, 2008 a copy of its designation dated February 12, 2008 (the "Designation"), of the Congregation Tifereth Israel located at 109-18 54<sup>th</sup> Avenue, Community District 4, Borough of Queens, as a landmark and Block 2010, Lot 1 in part, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on April 1, 2008 its report on the Designation dated March 26, 2008 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on April 15, 2008; and
