WHEREAS, the Landmarks Preservation Commission filed with the Council on October 15, 2009 a copy of its designation dated October 6, 2009 (the "Designation"), of the Edith Andrews Logan Residence, located at 17 West 56<sup>th</sup> Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 1272, Lot 25, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 7, 2009 its report on the Designation dated December 2, 2009 (the "Report");
