## Resolution affirming the designation by the Landmarks Preservation Commission of the Educational Building, 70 Fifth Avenue located at 70 Fifth Avenue (aka 2-6 West 13<sup>th</sup> Street) (Tax Map Block 576, Lot 36), Borough of Manhattan, Designation List No. 523, LP-2650 (L.U. No. 821; 20215018 HIM; N 210468 HIM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on May 27, 2021 a copy of its designation report dated May 18, 2021 (the "Designation"), designating the Educational Building, 70 Fifth Avenue located at 70 Fifth Avenue (aka 2-6 West 13<sup>th</sup> Street), Community District 2, Borough of Manhattan, as a landmark and Tax Map Block 576, Lot 36, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the New York City Charter and Section 25-303 of the Administrative Code of the City of New York;

WHEREAS, the City Planning Commission submitted to the Council on July 16, 2021, its report on the Designation dated July 14, 2021 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on August 4, 2021; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation.
