WHEREAS, the City Planning Commission filed with the Council on December 29, 1999 its decision dated December 22, 1999 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 711 and 715 East 176th Street, 710, 714, 716 and 718 Fairmount Place and 1883 Clinton Avenue (Block 2950, Lots 4, 7, 20, 22, 23, 24 and 26), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a sponsor/developer selected by the Department of Housing Preservation and Development (the "Disposition") (ULURP No. C 000053 HAX) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;
