Whereas, bills have been introduced in the New York State Legislature by Senator Velella, S.5842-A, and Assembly Member Abbate, A.10357, "AN ACT to amend the retirement and social security law, in relation to providing accidental disability retirement benefits for certain members of the uniformed force of the New York city department of sanitation"; and

Whereas, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
