WHEREAS, the Landmarks Preservation Commission filed with the Council on April 21, 2016 a copy of its designation dated April 12, 2016 (the "Designation"), of the Pepsi-Cola Sign and related site located at 4-09 47<sup>th</sup> Road, Long Island City, Community District 2, Borough of Queens, as a landmark and Tax Map Block 21, Lot 120, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on June 10, 2016, its report on the Designation dated June 8, 2016 (the "Report");
