THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1292

Resolution approving an Urban Development Action Area Project located at Pacific and Bergen Streets between Buffalo and Ralph Avenues and Pacific Street between Albany and Kingston Avenues (Block 1339/Lots 69, 70, 71, 72 and 76; Block 1344/Lots 100, 101, 108, 112 and 117; Block 1357/Lots 42, 43, 44, 45, 46, 47, 48 and 49; and Block 1210/Lots 34, 35, 36 and 37), Brooklyn, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 639; 20005174 HAK).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its request dated December 29, 1999 that the Council take the following actions regarding the following Urban Development Action Area Project (the "Project") located at Pacific and Bergen Streets between Buffalo and Ralph Avenues and Pacific Street between Albany and Kingston Avenues (Block 1339/Lots 69, 70, 71, 72 and 76; Block 1344/Lots 100, 101, 108, 112 and 117; Block 1357/Lots 42, 43, 44, 45, 46, 47, 48 and 49; and Block 1210/Lots 34, 35, 36 and 37), Borough of Brooklyn (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law;
  - 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law;

	WHEREAS, upon due notice, the Council held a public hearing on the Project on March 22, 2000;				
	WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Project;

	All of the value of the buildings, structures, and other improvements situated on the Disposition Area shall be exempt from local and pal taxes, other than assessments for local improvements and land value, for a period of six years commencing on the July 1st following veyance of the Disposition Area to the Sponsor, during the last ten years of which such exemption shall decrease in equal annual ents.				
b.	The partial tax exemption granted hereunder shall terminate with respect to all or any portion of the Disposition Area if the Departmen				

- of Housing Preservation and Development determines that such real property has not been, or is not being, developed, used, and/or operated in compliance with the requirements of all applicable agreements made by the Sponsor or the owner of such real property with, or for the benefit of, the City of New York. The Department of Housing Preservation and Development shall deliver written notice of any such determination of noncompliance to the owner of such real property and all mortgagees of record, which notice shall provide for an opportunity to cure of not less than ninety (90) days. If the noncompliance specified in such notice is not cured within the time period specified therein, the partial tax exemption granted hereunder shall prospectively terminate with respect to the real property specified therein.
