Whereas, bills have been introduced in the New York State Legislature by Senators Padavan, Golden, Maltese, Marchi and Velella, S.2564-B, and Assembly Members Abbate, Colton, Cymbrowitz, Ortiz, Pheffer, Seddio, Seminerio and McLaughlin, et al, A.5464-B, "AN ACT to amend the administrative code of the city of New York, in relation to the establishment of a twenty year retirement program for members of the New York city employees' retirement system employed as investigators by district attorneys' offices"; and
