A Local Law to amend the New York city charter to require notification to the council of emergency procurements.

Be it enacted by the Council as follows:

Section 1. Section 315 of the New York city charter, as amended by local law number 3 for the year 1997, is amended to

read as follows:

§315. Emergency Procurement. Notwithstanding the provisions of section three hundred twelve of this chapter, in the case of unforeseen danger to life, safety, property or a necessary service, an emergency procurement may be made with the prior approval

of the comptroller and corporation counsel, provided that such procurement shall be made with such competition as is practicable

under the circumstances, consistent with the provisions of section three hundred seventeen of this chapter. A written determination of

the basis for the emergency and the selection of the contractor shall be placed in the agency contract file, and shall further be

submitted to the council no later than fifteen days following contract award, and the determination or summary of such determination

shall be included in the notice of the award of contract published pursuant to section three hundred twenty-five of this chapter.

§2. This local law shall take effect 45 days after its enactment into law.
