Whereas, bills have been introduced in the New York State Legislature by Senator Padavan, S.61, and Assembly Member Clark, A.26, “AN ACT to amend the vehicle and traffic law, in relation to a fine for parked or unattended semitrailers or trailers on streets of a city with a population of one million or more”; and

Whereas, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
