WHEREAS, the City Planning Commission filed with the Council on May 28, 2003 its decision dated May 21, 2003 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 423, 421, 417, 415, 413 and 411 Chester Street, part of Site 22 within the Marcus Garvey Urban Renewal Area (Block 3589/Lots 12-17), as an Urban Development Action Area (the "Area");
- an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer selected by the Department of Housing Preservation and Development to facilitate the construction of a four-story building, tentatively known as Little Rock Manor, with 40 units of housing for formerly homeless persons with disabilities, to be developed under the New York/New York II Initiative Program, Community District 16, Borough of Brooklyn (the "Disposition") (ULURP No. C 030152 HAK) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;
