A Local Law to amend the administrative code of the city of New York, in relation to adjusting penalties for littering

Be it enacted by the Council as follows:

Section 1. Paragraph c of subdivision 9 of section 16-118 of the administrative code of the city of New

York, as added by local law number 75 for the year 2016, is amended to read as follows:

c. notwithstanding paragraph a of this subdivision, for any natural person violating subdivision 1 of this

section:

(1) 75 dollars for a first violation, and

(2) [not less than 250 and not more than 350] 300 dollars for any second violation within any 12 month

period, and

(3) [not less than 350 and not more than 450] 400 dollars for any third violation within any 12 month

period.

§ 2. This local law takes effect 120 days after it becomes law.
