WHEREAS, the Landmarks Preservation Commission filed with the Council on June 28, 2002 a copy of its designation dated June 18, 2002 (the "Designation"), of the Hamilton Heights/Sugar Hill Northwest Historic District generally bounded by Convent Avenue and West 151st Street and the west side of St. Nicholas Avenue, just south of West 151st Street, north to the southwest corner of St. Nicholas Avenue and West 155th Street, Borough of Manhattan, as its landmark site pursuant to Section 3020 of the New York City Charter;
