WHEREAS, the Landmarks Preservation Commission filed with the Council on December 28, 2011 a copy of its designation dated December 20, 2011 (the "Designation"), of the R. H. Macy & Co. Store, 14<sup>th</sup> Street Annex, located at 56 West 14<sup>th</sup> Street, Community District 2, Borough of Manhattan as a landmark and Tax Map Block 577, Lot 12, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on February 9, 2012 its report on the Designation dated February 8, 2012 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on March 20, 2012; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
