WHEREAS, the Landmarks Preservation Commission filed with the Council on April 5, 2012 a copy of its designation dated March 27, 2012 (the "Designation"), of the 36 Dominick Street House, located at 36 Dominick Street, Community District 2, Borough of Manhattan, as a landmark and Tax Map Block 578, Lot 62, as its landmark site pursuant to Section 3020 of the New York City Charter;
