WHEREAS, the Landmarks Preservation Commission filed with the Council on May 21, 2012 a copy of its designation dated May 15, 2012 (the "Designation"), of the Van Tassell & Kearney Auction Mart located at 126-128 East 13th Street, Community District 3, Borough of Manhattan, as a landmark and Tax Map Block 558, Lot 43 in part, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on July 13, 2012 its report on the Designation dated July 11, 2012 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on August 20, 2012; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
