Resolution approving the decision of the City Planning Commission on ULURP No. C 120177 PCM (L.U. No. 660), for the site selection and acquisition of property located at 512 West 23<sup>rd</sup> Street (Block 694, Lot 40) in Community District 4, Borough of Manhattan, for use as an ambulance station.

WHEREAS, the City Planning Commission filed with the Council on July 13, 2012 its decision dated July 11, 2012 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Fire Department of New York and the Department of Citywide Administrative Services for the site selection and acquisition of property located at 512 West 23<sup>rd</sup> Street (Block 694, Lot 40), Community District 4, Borough of Manhattan (the "Site"), for use as an ambulance station (ULURP No. C 120177 PCM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(3) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on August 20, 2012;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application; and

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration, issued on November 10, 2011 (CEQR No. 12FDO001M);

#### RESOLVED:

The Council finds that the action described herein will have no significant impact on the environment.
