WHEREAS, the Landmarks Preservation Commission filed with the Council on August 21, 2012 a copy of its designation dated August 14, 2012 (the "Designation"), of the Brinckerhoff Cemetery located at 69-65 to 69-73 182<sup>nd</sup> Street, Community District 8, Borough of Queens, as a landmark and Tax Map Block 7135, Lots 54 and 60, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on October 5, 2012 its report on the Designation dated October 3, 2012 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on October 23, 2012 and November 26, 2012; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

## RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
