No. 798; 20185050 HKM; N 180078 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on August 17, 2017 a copy of its designation report dated August 8, 2017 (the "Designation Report"), including the designation pursuant to Section 3020 of the New York City Charter and Chapter 3 of Title 25 of the Administrative Code of the City of New York of the New York Public Library (Stephen A. Schwarzman Building) Interiors, Main Reading Room and Catalog Room, located at 476 Fifth Avenue (aka 460-476 Fifth Avenue, 1 West 40<sup>th</sup> Street, 11 West 40<sup>th</sup> Street, 2 West 42<sup>nd</sup> Street), Community District 5, Borough of Manhattan, as an interior landmark and Tax Map Block 1257, Lot 1, as its landmark site (the "Designation");
