A Local Law in relation to a plan to increase enforcement of littering out of vehicles

Be it enacted by the Council as follows:

File #: Int 0851-2018, Version: \*

Section 1. The commissioner of sanitation shall develop and submit to the mayor and the speaker of the

council by April 1, 2019, a plan to increase enforcement of subdivision 4 of section 16-118 of the

administrative code of the city of New York. This plan shall include but not be limited to:

a. a list of locations in the city where litter is commonly thrown from cars, which shall be developed by

such commissioner in consultation with council members and community boards;

b. the number of sanitation officers necessary to enforce such subdivision in such locations;

c. the number of violations issued annually for littering out of a vehicle, disaggregated by sanitation

district;

d. a description of steps the department of sanitation will take to increase enforcement of such

subdivision; and

e. a timeline for implementation of such plan.

§ 2. This local law takes effect immediately.
