WHEREAS, the Landmarks Preservation Commission filed with the Council on March 15, 2018 a copy of its designation report dated March 6, 2018 (the "Designation Report"), including the designation pursuant to Section 3020 of the New York City Charter and Chapter 3 of Title 25 of the Administrative Code of the City of New York of the Hotel Seville (now The James Nomad Hotel) located at 22 East 29<sup>th</sup> Street (aka 18-20 East 29<sup>th</sup> Street, 15-17 East 28<sup>th</sup> Street and 90-94 Madison Avenue), Community District 5, Borough of Manhattan, as an historic landmark and Tax Map Block 858, p/o Lot 17, as the landmark site (the "Designation");

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the New York City Charter;
