Resolution affirming the designation by the Landmarks Preservation Commission of the 826 Broadway Building (now the Strand Building) located at 826 Broadway (aka 826-828 Broadway and 57-63 East 12<sup>th</sup> Street) (Tax Map Block 564, Lot 34), Borough of Manhattan, Designation List No. 512, LP-2615 (L.U. WHEREAS, the Landmarks Preservation Commission filed with the Council on June 20, 2019 a copy of its designation report dated June 11, 2019 (the "Designation"), of the 826 Broadway (now Strand Building) located at 826 Broadway (aka 826-828 Broadway and 57-63 East 12<sup>th</sup> Street), Community District 2, Borough of Manhattan, as a landmark and Tax Map Block 564, Lot 34, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the New York City Charter and Section 25-303 of the Administrative Code of the City of New York;

WHEREAS, the City Planning Commission submitted to the Council on August 16, 2019, its report on the Designation dated August 14, 2019 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on September 4, 2019; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation.
