A LOCAL LAW

In relation to four street names, East 21st Street/Kenmore Place, East 22nd Street/Elmore Place, East 23rd Street/Delamere Place and East 24th Street/Mansfield Place, Borough of Brooklyn.

Be it enacted by the Council as follows:

Section 1. The following street name is hereby designated as hereafter indicated.

East 24 Street/Mansfield Place	East 24 Street	between Glenwood Road and Foster Avenue

§5. This local law shall take effect immediately.
