WHEREAS, the Landmarks Preservation Commission filed with the Council on October 27, 1999 a copy of its designation dated October 19, 1999 (the "Designation"), of 140 West 57th Street Studio Building (The Beaufort), located at 140 West 57th Street (aka 134-140 West 57th Street), Borough of Manhattan, as a landmark and Block 1009, Lot 50, as its landmark site pursuant to Section 3020 of the New York City Charter:

WHEREAS, the City Planning Commission submitted to the Council on December 13, 1999, its report on the Designation dated December 8, 1999 (the "Report");
