WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its request dated November 3, 1999 that the Council take the following actions regarding an Urban Development Action Area Project (the "Project") located at 14 -16 West 127 Street (Block 1724/Lot 44), 141-43 West 127 Street (Block 1912/Lot 10), 103 West 127 Street (Block 1912/Lot 26), 22 West 128 Street (Block 1725/Lot 46), 24 West 128 Street (Block 1725/Lot 47), 51 West 128 Street (Block 1726/Lot 16), 60 West 128 Street (Block 1725/Lot 64), 64 West 128 Street (Block 1725/Lot 66), 73 West 128 Street (Block 1726/Lot 9), 75 West 128 Street (Block 1726/Lot 8), 77 West 128 Street (VL) (Block 1726/Lot 7), 79 West 128 Street (Block 1726/Lot 6), 27-29 West 129 Street (Block 1727/Lot 21), 102 West 129 Street, aka 373 Lenox Avenue (Block 1913/Lot 35), and 2193 7 Avenue (VL), aka 2193 Adam Clayton Powell Boulevard (Block 1914/Lot 63), Borough of Manhattan (the "Disposition Area"):

1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the

municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes of Section 691 of the General Municipal Law;

- 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law; and
- 4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law;

WHEREAS, the Project is to be developed on land that is now a municipally-owned area as defined in Section 692 of the General Municipal Law, consists solely of the rehabilitation or conservation of existing private or multiple dwellings or the construction of one to four unit dwellings, and does not require any change in land use permitted under the New York City Zoning Resolution;

WHEREAS, upon due notice, the Council held a public hearing on the Project on February 16, 2000;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Project;

RESOLVED:

The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council waives the area designation requirement of the Disposition Area as an urban development action area under Section 693 of the General Municipal Law pursuant to said Section.

The Council waives the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law.

The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.
