WHEREAS, the City Planning Commission filed with the Council on March 22, 2000 its decision dated March 15, 2000 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of two (2) city-owned properties pursuant to zoning, located on College Point Boulevard (Block 4386/Lot 1) and on 31st Road (Block 4386/part of Lot 24), Borough of Queens (ULURP No. C 000157 PPQ) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(3) of the City Charter;
