WHEREAS, the City Planning Commission filed with the Council on March 22, 2000 its decision dated March 15, 2000 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of eleven (11) city-owned properties pursuant to zoning, located at 28 Bradhurst Avenue (Block 2044/Lot 4) and 315 West 145th Street (Block 2045/Lot 2), Borough of Manhattan (ULURP No. C 990008 PPM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(3) of the City Charter;
