Halleck Street on the east, Halleck Street and the property line of the Port Authority Grain Terminal on the south, Columbia Street between the property line of the Port Authority Grain Terminal and Halleck Street on the west, Halleck Street between Columbia Street and Otsego Street on the south and Otsego Street between Halleck Street and Bay Street on the west.

§2. This local law shall take effect immediately.
