WHEREAS, the Landmarks Preservation Commission filed with the Council on April 11, 2000 a copy of its designation dated March 28, 2000 (the "Designation"), of the (Former) American Female Guardian Society and Home for the Friendless Woody Crest Home, located at 936 Woodycrest Avenue, Borough of the Bronx, as a landmark and Block 2504, Lot 6, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on June 5, 2000, its report on the Designation dated May 31, 2000 (the "Report");
