WHEREAS, the City Planning Commission filed with the Council on September 22, 2000 its decision dated September 20, 2000 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of five (5) city-owned properties pursuant to zoning, located at 1842 Park Avenue (Block 1751/Lot 34), 60 East 131st Street (Block 1755/Lot 45), 58 East 131st Street (Block 1755/Lot 146), 180 East 122nd Street (Block 1770/Lot 141), and 114 East 123rd Street (Block 1771/Lot 66), Borough of Manhattan (ULURP No. C 000294 PPM) (the "Application");
