### THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1642

Resolution approving the site plan for Public School 194-Bronx (P.S./I.S. 194-X), to be located at 1301-59 Zerega Avenue, The Bronx (Non-ULURP No. 20015031 SCX; L.U. No. 923).

WHEREAS, the New York City School Construction Authority submitted to the Council on November 21, 2000, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a public school facility known as Public School 194-Bronx (P.S./I.S. 194-X), a 991-seat elementary and intermediate school to serve Community School District 11, to be located at 1301-59 Zerega Avenue (Block 3834/Lot 70), Borough of the Bronx (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on November 27, 2000;

WHEREAS, the Council has considered the relevant environmental issues and the Conditional Negative Declaration issued August 28, 2000 (SCA Project Number 00-016); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;

RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment; and
