WHEREAS, the City Planning Commission filed with the Council on January 12, 2001 its decision dated January 8, 2001 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of one (1) city-owned property pursuant to zoning, located at International Airport Center Boulevard (Rockaway Boulevard) (Block 13791/part of Lot 21) Borough of Queens (ULURP No. C 000305 PPQ) (the "Application");

WHEREAS, the Application is related to Applications Number C 000272 MMQ (L.U. No. 874), an amendment to the City Map and C 000304 ZMQ (L.U. No. 875), an amendment to the Zoning Map;
