WHEREAS, the City Planning Commission filed with the Council on January 8, 2001 its decision dated December 27, 2000 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Housing Preservation and Development, for disposition to the Economic Development Corporation of one (1) city-owned property located at 159 E. 126th Street (Block 1775/Lot 28), Borough of Manhattan (ULURP No. C 000543 PPM) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 000544 HUM (L.U. No. 878), an amendment to the urban renewal plan.
