WHEREAS, the Landmarks Preservation Commission filed with the Council on December 8, 2000 a copy of its designation dated November 28, 2000 (the "Designation"), of the American Seamen's Friend Society Sailors' Home and Institute located at 505-507 West Street (a.k.a. 113-119 Jane Street), Borough of Manhattan, as a landmark and Block 642/Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on January 23, 2001, its report on the Designation dated January 17, 2001 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on February 13, 2001; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

### RESOLVED:
