No. 832-A, a Local Law to amend the administrative code of the city of New York, in relation to banning gauges that use mercury to test gas piping, drainage and vent systems and banning the sale of such mercury gauges and replacement mercury; and

Whereas, The attached Environmental Assessment Statement and Negative Declaration represent the findings and conclusions of the Council; now, therefore, be it

Resolved, That the Council of the City of New York hereby determines that the enactment of Proposed Int. No. 832-A will not have a significant adverse impact on the environment.
