A Local Law in relation to a park name, John V. Lindsay Park, Borough of Manhattan.

Be it enacted by the Council as follows:

Section 1. The following park name is hereby designated as hereafter indicated.

New name	Present name	Limits
John V. Lindsay/East River Park	East River Park	existing park between Franklin D. Roosevelt Drive and the East River from Montgomery Street to East 12 th Street

§2. This local law shall take effect immediately.
