WHEREAS, the City Planning Commission filed with the Council on February 22, 2001 its decision dated February 14, 2001 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, pursuant to zoning for the disposition of three (3) three city-owned properties located at 434 West 119th Street (Block 1962/Lot 35), 573 Riverside Drive (Block 2001/Lot 2) and 1850 Amsterdam Avenue (Block 2083/Lot 33) Borough of Manhattan (ULURP No. C 000041 PPM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(3) of the City Charter;
