WHEREAS, the Landmarks Preservation Commission filed with the Council on May 10, 2001 a copy of its designation dated May 1, 2001 (the "Designation"), of Mary Hale Cunningham House located at 124 East 55th Street, Borough of Manhattan as a landmark and Block 1309, Lot 62 as its landmark site, pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on July 2, 2001 its report on the Designation dated June 27, 2001 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on July 25, 2001; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
