WHEREAS, the Landmarks Preservation Commission filed with the Council on July 5, 2001 a copy of its designation dated June 26, 2001 (the "Designation"), of the (Former) Sunset Park Courthouse, located at 4201 Fourth Avenue, Borough of Brooklyn as a landmark and Block 724, Lot 1 as its landmark site, pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on August 16, 2001 its report on the Designation dated August 8, 2001 (the "Report"):
