A Local Law in relation to a street name, Lewis Rudin Way, Borough of Manhattan.

Be it enacted by the Council as follows:

Section 1. The following street name is hereby designated as hereafter indicated.

<b>New name</b>	<b>Present name</b>	<b>Limits</b>
Lewis Rudin Way	East 52 <sup>nd</sup> Street	between Lexington Avenue and Park Avenue

§2. This local law shall take effect immediately.
