WHEREAS, the City Planning Commission filed with the Council on November 14, 2001 its decision dated November 7, 2001 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, the disposition of four (4) city-owned properties pursuant to zoning, located at 90-09 Van Wyck Expressway (Block 9972/Lot 1), VL Eveleth Road (Block 12458/Lot 160), VL Eveleth Road (Block 12458/Lot 163), and VL 196th Street (Block 12652/Lot 47), Borough of Queens (ULURP No. C 010620 PPQ) (the "Application");
