Resolution approving the decision of the City Planning Commission on an application submitted by the Department of Housing Preservation and Development, ULURP No. C 010714 HAM, approving the designation of 1991, 1995 and 2001 First Avenue and 336 E. 103rd Street, Site 7 within the Metro North I Urban Renewal Area (Block 1674/Lot 23), as an Urban Development Action Area, approving the project for the area as an Urban Development Action Area Project and approving the disposition of such property to a developer selected by the Department of Housing Preservation and Development (L.U. No. 1144; C 010714 HAM).

WHEREAS, the City Planning Commission filed with the Council on November 8, 2001 its decision dated November 7, 2001 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- the designation of 1991, 1995 and 2001 First Avenue and 336 E. 103rd Street, Site 7 within the Metro North I Urban Renewal Area (Block 1674/Lot 23), as an Urban Development Action Area (the "Area");
- an Urban Development Action Area Project for such area (the "Project"); and b)

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer selected by the Department of Housing Preservation and Development to facilitate the construction of a building with approximately of 231 units of housing, neighborhood retail and community facility space (the "Disposition") (ULURP No. C 010174 HAM) (the "Application"), Borough of Manhattan;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its recommendations regarding the Application on November 8, 2001;
WHEREAS, upon due notice, the Council held a public hearing on the Application and Decision on December 3, 2001;
WHEREAS, the Council has considered the relevant environmental review (CEQR No. 01HPD009M) and the fact that a Negative Declaration was issued on April 19, 2001;
WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Application;
RESOLVED:
The Council finds that the actions described herein will have no significant effect on the environment;
Pursuant to Section 197-d, the Council approves the decision of the City Planning Commission (C 010714 HAM).
The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.
The Council approves the designation of the Disposition Area as an urban development action area pursuant to Section 693 of the General Municipal Law.
The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law
The Council approves the disposition of said property to a developer selected by the Department of Housing Preservation and Development.
